Community Policing-41 calls for the month of November

Fire Department-Chief Sheridan reported there were 13 calls in November. There is a new member and he is enrolled in the fire academy. Mark McDonald will step down as lieutenant and Rob Haack will take the position. Galen Rosel will step down as medical officer, Deb Burgtorf will take the position. Asked if there is a protocol to sell the Tahoe. Board responded to put on Facebook Marketplace for one month. Radios will be re-programmed on December 17<sup>th</sup>. Parking lot is complete. Department Physicals will take place in December. Chester Township Fire Dept is applying for a grant with Hudsonville Fire Dept for SBCA equipment. The NEOFC fundraiser and auction will take place on March 12<sup>th</sup>. Santa was in Conklin on December 11<sup>th</sup>. 150 people showed up. Thank you to Coopersville Cares and Marian Kelly for donations to the event.

Planning Commission-At the November meeting the board voted to recommend to send the Lawful Nonconforming Lots, Uses, Structures and buildings ordinance to the Township Board. Mr. Goodno gave a brief history as to why the ordinance was reviewed. The proposed ordinance is not stricter than the current ordinance in regards to the 60% rule. Residents can go through the Zoning Board of Appeals to obtain the ability to rebuild. The draft contained language to eliminate over time all nonconforming properties which was removed.

A Special use land division proposal was reviewed, two splits were requested, one was allowed.

Migrant Farm Labor Housing was reviewed, Farm Bureau gave a presentation. A draft ordinance will be reviewed based on feedback from the Planning Commission. There will be an extra meeting on January 3<sup>rd</sup> at 7pm.

Lawful Nonconforming Lots, Uses, Structures and Buildings Ordinance.

- St Patricks Day Celebration-The Marne American Legion along with the Conklin legion would like to have a beer tent on Grove St or Main St. The board was in favor of the idea and will re-visit at the January meeting.
- PLM-Crockery Lake Weed Control. Betsy Ludwick from the Crockery Lake Association presented the weed control contract. Motion by Meerman to approve the contract for three years, Second by Dunnuck, motion carries.
- Road Projects 2022-The cost to repave Conklin is \$292,503. The roads in Conklin and around Crockery Lake are the responsibility of the Township. Ottawa County takes care of all other roads.
- Lighting Estimates-Two estimates were submitted for the Hall portion of the building. Motion by Meerman to accept Hersh bid with the caveat that we do not have a supply of ballasts on hand. Second by Dietrich, motion carries.
